Important Notes : "Grant with Conditions:- 1) Public disclosure uploaded not seems to be as per norms. The school is required to upload Mandatory public disclosure as per appendix -IX of Affiliation Bye-laws. 2) Building Safety Certificate submitted by the school is issued from the Professor of NITK Mangalore instead of competent govt Authority. School authority is required to obtain Building Safety Certificate issued by Competent Govt. Authority of concerned department (PWD) or issued by govt empanelled engineer along with copy of license issued by competent govt authority. The copy of Building Safety Certificate along with copy of license is required to be uploaded in the public disclosure on the school website as per Appendix IX of Affiliation Bye Laws. 3) Fire Safety certificate uploaded is not found as per norms as it is related to fire safety recommendations / Compliance Report of fire safety recommendations only, which is not acceptable. School is therefore, required to obtain a valid copy of fire safety certificate issued by the Fire Safety Department of the State/UT of appropriate government authority of concerned Municipal Corporation etc. based on the inspection of the fire safety department. It should be mentioned in the certificate that the building is safe in terms of fire. The same is required to be uploaded in the public disclosure link on the school website as per Appendix IX of affiliation bye laws. 4) Infrastructure photos (library, labs, playground, toilets, etc.) have not been uploaded in Part B uploads. 5) Library and Maths lab of the school are undersized. School is required to shift the library to bigger room size of 1200 sq ft and Maths lab to a bigger room size of 500 sq ft and upload photo and size details

in the public disclosure link of school website. 6) School is required to appoint Special Educator as per norms.⁷⁾ School is required to maintain student teacher ratio at each level as per norms of the Board. The extension is granted to the school on one time basis subject to condition that school will follow the instructions and fulfill the conditions given in the Board's circular no. 13/2021 dated 23-07-2021."
