With reference cited (2) above, the Principal of Bhuvana Jyothi Residential School had requested for the issue of Fire Safety Compliance Certificate from our department. In this regard inspected the School building by Fire Station Officer Moodabidre on 13-11-2025 and has submitted his report on 14-11-2025. In his report, the Fire Station Officer Moodabidre has confirmed the compliance of fire fighting measures fully, that were communicated Fire Safety recommendation vide ref(1) with 07 employee's trained in 2 days fire prevention & fire fighting training at Regional Training Centre, kadri Fire Station Premises, Kuntikana, Mangaluru .

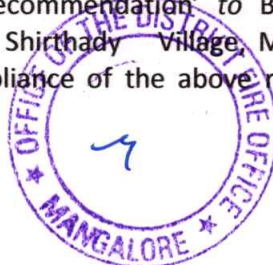

15. **Fire precautionary measures :-**

- A. Explosive and flammable materials should not be stored in the store room, UPS room, Electrical panel area, class rooms, laboratory & electrical sum panel premises.
- B. Accumulation of combustible waste in and around the premises should be avoided.
- C. The exit ways shall be always kept clear without any obstruction.
- D. Liquefied petroleum gas should not be stored in the building.
- E. The doors shall not be kept locked / latched during working hours and shall be free from obstruction.
- F. During the class hours the class room doors shall not be locked from inside to out side.
- G. As per Hon'ble supreme court order all teachers and staffs shall be trained to handle safety equipment, initiate emergency evacuation and protect their students in the event of fire and other emergency and the school shall observe the Fire Safety Day on April 14th of every year by conducting Fire Safety drills with co-ordinate with fire service department.

Under the above circumstance the Karnataka Fire & Emergency Service Department is issuing 'Revised Fire safety recommendation' to Bhuvana Jyothi Residential School building constructed at Sy.No.136/P3 Shirthady Village, Moodabidri Taluk, Dakshina Kannada District, subject to condition and compliance of the above recommendations in column -4 of serial – B



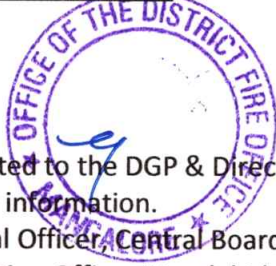
